

# HYSSOP Care Sober Recovery Homes

## Resident Agreement

Director is on call 24 hours for your safety. The house representative will call in case of emergency, but all clients must be always accountable for their actions and the house. If the house representative is not available, the clients must alert the Director immediately. Numbers are placed where all clients can always access them. Violations of any of the below house rules may result in immediate disciplinary action which includes discharge from the facility and possible criminal charges.

1. Residents will clean room daily – No Exceptions
2. Church is mandatory unless it goes against your beliefs. Otherwise, you will be asked to attend the first two Sundays with peers and after that may attend church of choice. Residents must return with program (For your safety).
3. Chores are to be completed in a timely manner.
4. HYSSOP Care Sober Recovery Homes can and will administer UA's or BAC randomly or on an as needed base.
5. HYSSOP Care Sober Recovery Homes believes Medication is important. HYSSOP Care Sober Recovery Homes does not dispense medication nor are we responsible for medication. Residents are encouraged to take all medications as prescribed by their medical doctor and psychiatrists. Mood altering medications are strictly prohibited. No narcotic medications are allowed without prior approval. Do not fill these prescriptions! There is absolutely NO medications sharing; all medications need to be safely put away. All medication requires a lockbox. Any medication that is lost or stolen should be reported to house staff or owner immediately.
6. Confidentiality is mandatory for all concerned. Your response should always be "I can not confirm or deny".
7. Overnight guest are NOT permitted at HYSSOP Care Sober Recovery Homes
8. Visitors may only visit during visiting hours and may only visit in common areas. Visitors can stay up to 2 hours at a time and may not be left unaccompanied.
  - Visiting hours are as follows:
    - Monday: 5:00pm – 9:00pm
    - Friday: 2:00pm – 9:00pm
    - Saturday & Sunday: 12:00pm – 3:00pm & 4:00pm – 9:00pm
9. Any resident knowing of any dangerous situations must report them.
10. Residents are to attend outpatient treatment, all activities and in house meetings.
11. No confrontations with other residents or the house representatives are allowed. All problems must be written up and handled in a supervisory setting.
12. No illegal drugs or unauthorized prescriptions or over the counter medications are permitted on the premises by residents or visitors without checking with the Director first.
13. Any literature which depicts violence, graphic sexual material, pornography, or glorification of alcohol or drugs is not allowed in the home.
14. Intimate, romantic, or sex relationships between residents or staff in the house are prohibited while at HYSSOP Care Sober Recovery Homes
15. Borrowing or lending money, cloths, vehicles, etc. from residents or staff members is prohibited.

16. Due to health codes, body piercing or tattooing of any kind is prohibited during residency.
17. All open packages of food must be kept in closed containers.
18. Residents are discouraged from bringing personal items of value over \$50 into the home. Game systems, jewelry, laptops, expensive clothing, and other valuables should not be brought into the home. Staff persons are not responsible for lost or stolen personal items. HYSSOP Care Sober Recovery Homes is not liable for any personal property during or after the resident's discharge from the house. HYSSOP will dispose of all personal property 1 week after discharge from the program unless other arrangements have been agreed upon. HYSSOP assumes no responsibility for the personal property of residents.
19. Residents are encouraged to be productive and are expected to have at least 20 hours of productivity hours per week. Productivity includes work, school, volunteer, church, 12 step meetings, and meeting with sponsor. All sobriety commitments should take priority.
20. Smoking is not allowed in the house. NO EXCEPTIONS. Smoking is permitted in the back of the house ONLY! All ashtrays must be kept clean and in the designated area.
21. Verbal threats or physical contact will not be tolerated. Any threats to residents or staff may result in immediate discharge. Physical assaults on staff or residents will result in legal action and immediate removal from the home.
22. Residents are required to attend (2) 12 STEP recovery meetings a week and (2) outpatient groups per week. Documentation must be provided for all meetings attended.
23. Cursing, fighting, or gossiping amongst other residents is unacceptable and grounds for discharge
24. Having unauthorized visitors is grounds for discharge.
25. No one should reveal the identity of any other residents. Doing so are grounds for immediate removal.
26. If you have medication and are not taking them is means for removal.
27. Nonpayment of housing fee is means for removal
28. Please be respectful of you housemates by keeping your music at a level that can be heard only by you. Headphones, walkmans, iPods, etc. are required. Quiet hours are from 10:00pm – 10:00am
29. If you can not follow the house rules and continue breaking the rules you will be removed.
30. This is not a standard/landlord/tenant lease; this is a sober housing agreement. The owner of HYSSOP Care Sober Recovery Homes may at any time and for any reason ask any resident to immediately vacate the property.
